Note: It is not possible to do accounting in the check step. The accounting on the invoice has to be done in the DCE web application.

New features

General

Search user functionality

Select recipients for Reject action use new search user function. **Select recipients** will display a new view with list of user.



Note: List of user includes only user with corresponding rights for started action.

When start typing to search for specific users, list is filtered and user(s) containing in their id the typed characters will be displayed in list. User(s) can be marked as selected and when **OK** button will be hit he(they) will be set as recipients.



Note: Preselected recipients are already displayed as marked.



Note: Selection can be undone by unmarking the selected users and hit **OK**.

Localization/Globalization

Same culture (languages) supported in DCE main application are supported in DCE Mobile web application. User can select the language from actions menu **Select language**. Selected language will be kept until new selection will be done.

New features

General

Mobile Web Application

DCE Mobile solution was built to approve/reject invoices using mobile devices.



Note: DCE Mobile solution is a web application, therefore can be accessed only via browsers installed on mobile device.

The application provides access to visualize the invoices ready for attest from user's personal queue. Invoices are displayed as a list and each invoice can be opened in read only mode to visualize its details. For each invoice basic details, attached image and accounting table are displayed. Image and accounting table can be accessed by direct links from invoice details view.



Note: All invoice information are displayed in read only mode, they cannot be changed.

How to access mobile web application

Open the device browser (default or installed) and insert the link to the mobile application. Login page will be displayed and credentials required. Insert same credentials used to connect to DCE application.

Mobile web application components

From the case list, each invoice can be opened by selecting it (tap on desired invoice). Following invoice details will be displayed: unit name, invoice original number, invoice amount, invoice date and invoice due date. On the invoice details a list of messages related to the invoice will be added, latest message will be displayed first. Each message is accompanied by the date and the user who posted it. On invoice details there will be links to invoice accounting and invoice image. Accounting view will provide same information as the application on accounting grid (all visible and edited fields from accounting grid will be displayed). Invoice image will provide zoom in and zoom out functions for a better view of the details.

Approve invoice

Invoice can be approved from all views where button is available: invoice details, invoice image, invoice accounting.



Note: Confirmation is required.

If the user has attest rights for all accounts and objects, all the rows will be automatically signed, invoice will be processed and removed from user's personal queue, otherwise the invoice should be forwarded to another user with rights for the remaining unsigned rows.

Reject invoice

Invoice can be rejected from all views where button is available: invoice details, invoice image, invoice accounting. There are three options for reject action: send back to check, investigate the invoice, forward the invoice to another user. According to selected action, necessary information has to be fulfilled: addressed user, mandatory message.
